New Aged Care Diversity Framework

The Minister for Aged Care, the Hon Ken Wyatt AM, MP, has launched the Aged Care Diversity Framework.

The Framework will help the aged care sector ensure that older people receive aged care services appropriate to their diverse needs.

Under the Framework, three action plans are being developed and due for release in May 2018, to address the specific barriers and challenges faced by:

- Aboriginal and Torres Strait Islander people
- culturally and linguistically diverse communities
- people who identify as Lesbian, Gay, Bisexual, Transgender or Intersex (LGBTI).

Supporting Tools and Resources

The Framework is supported by existing tools and resources including legislation, complementary frameworks, and information and training. One optional tool which may assist aged care providers to consider the diverse characteristics and life experiences of their clients and workforce is the Sample Provider Diversity Plan. Providers can tailor the plan to suit their individual circumstances.

Prepare For The End of the Reporting Period Now!

DON'T LEAVE IT TILL THE Last Minute

DEX is commencing their preparations for the end of the reporting period on 31 December 2017. You will be able to enter data for this reporting period up to 30 January 2018.

Please don't wait until the last minute......

You are encouraged to enter data regularly, you can view this data in the self-service reports. For organisations that bulk upload, it is recommend regular uploads to help identify errors early and ensure you have Helpdesk support when needed.

The system speed can be impacted by a number of organisations attempting to upload data at the same time, particularly around the close of reporting period. This can result in a longer upload timeframe, and limited time to correct errors before the system closes. Please ensure you upload your data well before the end of the closing date to avoid this happening to you. [This happened the last Friday before the portal closed in July; remember this is a National system]

You can view the organisation overview report to understand the quality of your data and ensure it is consistent with local intelligence. If you find any inconsistencies, your organisation still has time to correct and submit the data before the close of reporting.


Connecting Through Inclusive Communication Practices

Ladder Safety Matters

Ladders are associated with more deaths and injuries than any other household product and men over the age of 60 are over-represented in the statistics (Monash University Accident Research Centre, 2014).

That's why the Victorian Government is running the *Ladder Safety Matters* campaign: to prevent serious injury and deaths from domestic ladder falls. It is a collaborative project between the Department of Health and Human Services and the Department of Justice and Regulation (Consumer Affairs Victoria).

The campaign encourages older men to make safety a priority when using a ladder, as well as considering the consequences of unsafe ladder use – not just the risk of a fall, but what could happen after a fall.

The campaign highlights 3 personal video-stories and promotes the fact that almost every ladder injury is preventable. The campaign encourages men to practice ladder safety, to remain active and independent.

The Ladder Safety Matters campaign page on the Better Health Channel hosts a number of resources available for download, including the 3 videostories, an A3 poster, and A4 brochure.
